



- (2) POLYGUARD DETAIL SEALANT PW APPLIED AND TOOLED TO MINIMUM 90 MILS TO SEAL AROUND BASE OF SECURED PIPE PENETRATION
- (1) SECURED PIPE PENETRATION, CLEAN AND ABRABE IN PREPARATION FOR POLYGUARD FLASHING MATERIALS
- (3) FIRST PIECE: HIGH-TECH PIECE OF POLYGUARD AIRLOK SHEET 200 BU / NP, AIRLOK SHEET 400 NP, OR AIRLOK SHEET 400 HT / NP, EXTEND MINIMUM 3" ONTO EACH SURFACE WITH RELIEF CUTS ONTO VERTICAL WALL
- (4) POLYGUARD DETAIL SEALANT PW APPLIED AND TOOLED TO MINIMUM 25 MILS TO COVER EXPOSED SHEET FLASHING MEMBRANE EDGE AROUND PENETRATION
- (5) SECOND PIECE: POLYGUARD AIRLOK SHEET 200 BU / NP, AIRLOK SHEET 400 NP, OR AIRLOK SHEET 400 HT / NP, EXTEND MINIMUM 6" ONTO VERTICAL WALL SURFACE AROUND PENETRATION TO COVER ALL RELIEF CUTS AND EXTEND MINIMUM 3" BEYOND RELIEF CUTS. PROVIDE ROUNDED OUTSIDE CORNERS
- (8) POLYGUARD DETAIL SEALANT PW APPLIED AND TOOLED TO MINIMUM 25 MILS TO COVER EXPOSED SHEET FLASHING MEMBRANE TOP EDGES
- (7) PROVIDE FILLET / ROUNDED EDGES ON SHEET FLASHING EXPOSED OUTSIDE CORNERS
- (6) THIRD PIECE: POLYGUARD AIRLOK SHEET 200 BU / NP, AIRLOK SHEET 400 NP, OR AIRLOK SHEET 400 HT / NP, EXTEND MINIMUM 6" ONTO VERTICAL WALL SURFACE AROUND PENETRATION TO COVER ALL RELIEF CUTS AND EXTEND MINIMUM 3" BEYOND RELIEF CUTS
- (9) POLYGUARD DETAIL SEALANT PW APPLIED AND TOOLED TO MINIMUM 25 MILS TO COVER SHEET FLASHING MEMBRANE EDGES AROUND SECURED PENETRATION
