# PRODUCT DESCRIPTION Basic Uses

California Sealant is an integral part of Polyguard Underseal® Membrane systems. Sufficient primer must be used on the porous geotextile substrate of the Underseal membrane to condition the surface so that the substrate is suitable for the application of Polyguard sealants.

California Sealant is a porous architectural sealant used to promote sealing laps and areas of penetration of the Underseal® Underslab and Underseal® Blindside where geotextile fabric will be joined by Polyguard sealants to the adjoining membrane and surrounding substrates. The function of the sealant is to seal all porous portions of the geotextile surface and promote adhesion of Polyguard sealants such as LM-85 SSL, LM-95, Detail Sealant PW<sup>™</sup> and Underseal® Fabric Tape.

# **PRODUCT FEATURES**

- Used to prime Underseal systems components and all joining substrates such as structural concrete, masonry, or wood surfaces on which Polyguard sealants will be applied.
- Designed to be used on applications down to 25° F (-4° C).

# **COMPOSITION & MATERIALS**

California Sealant is a rubber-based sealant primer which is specifically formulated to promote excellent adhesion of Polyguard sealants.

The VOC (Volatile Organic Compound) content meets the South Coast Air Quality Management District regulations established under the February 1, 1991 version of Rule 1168 ©) (2) Adhesion and Sealant Applications. California Sealant is classified as an Architectural Sealant Primer Porous, with VOC of 527 g/L. Current SCAQMD regulations for this type sealant primer are 775 g/L.

California Sealant will be orange color in appearance.

# **TECHNICAL DATA**

# INSTALLATION

California Sealant may be applied with roller or brush. A roller with a heavy nap should be used to carry sufficient material to the area being coated.

Apply California Sealant to a clean, dry, dust free, and frost-free geotextile surface of the Underseal® at a coverage rate of approximately 50 to 75 square feet per gallon. Specific testing for coverage is recommended. Other substrates may vary in coverage, please test according. The sealant primer should be spread sufficiently to avoid areas of excess material. Areas of excess material will affect the cure time of the Polyguard sealants applied to the California Sealant.

# LIMITATIONS

The application of sealant primer should be limited to what can be covered with Polyguard sealants in one working day. Any areas not covered with sealants during the day must be recoated; be sure to cover all open containers when not applying sealant primer. If sealant primer dries and is no longer tacky, then reapply sealant primer.

When used on horizontal surfaces, the sealant primer remains tacky, and precautions must be used in this application.
